United States Department of Agriculture:

We are pleased to provide this letter in support of a grant request by a recently formed 501 c (3) non-profit organization, the "Northwest Food Processing & Innovation Center." The funding will be used to aid in the construction costs of a new regional livestock processing facility in Warren County, New Jersey.

The proposed facility will benefit the region's livestock producers who currently have no facility to process their cows and pigs in New Jersey. Small facilities in Pennsylvania are unreliable and at capacity and are the only reasonable outlets for producers. This is a major hurdle for a producer who wants to expand their livestock operations and make their farming profitable. This facility is a major piece of agricultural infrastructure that has been lacking for decades. The Warren County Commissioners are supporting the facility and want to see it succeed.

A regional processing facility will enable farmers in the Northwest New Jersey region to expand their livestock operations or to create new operations. Lands that are currently deep tilled for corn, soybean and other commodity crops can be easily converted to livestock pasturing lands which can have considerable environmental benefits. The North Jersey RC&D Council has a Regenerative Farm Network supporting farmers interested in learning and exchanging knowledge regarding regenerative and climate-smart farm practices. These new and expanded operations will have a processing facility in close proximity with adequate capacity to enable them to grow their operations. Livestock producers will have the ability to sell their animals to the non-profit that is running the facility. There is also the option to have the facility process their animals and return finished cuts wrapped for sale under the producer's own brand, thereby increasing economic development for the agricultural industry.

To whom it may concern:

As Assistant Secretary of Agriculture fulfilling the role of Secretary, I am submitting this letter of support for the "NW New Jersey Food Processing & Innovation Center, Greenfield Processing Plant," as well as detailing the various segments conducted by the state and showing the critical need of funding for this project in New Jersey.

The New Jersey Department of Agriculture (NJDA) identified the critical need of all New Jersey red meat livestock producers in early 2019 and commenced studies to establish and expand processing for individual producers for custom-labeled processed meats and the potential of house-branded products for the community of livestock producers that did not want to or could not direct market on an individual basis.

Rutgers Cooperative Extension Board of Managers also reviewed the needs of the state. Both agencies conducted livestock summit outreach meetings to producers with unprecedented attendance, interest, and follow-up questions. From the various outreach efforts, it was apparent that multiple models were being discussed by the producer clientele to help satisfy the processing needs lacking within the state.

In March 2019, NJDA submitted a Rural Business Development Grant Application to conduct "A Comparative Analysis and feasibility study of three models of processing facilities to serve NJ livestock farmers." With this awarded grant, NJDA was able to solicit the services of Keystone Development Center (KDC), a member of the USDA-supported Mid-Atlantic Food Cooperative Alliance (MAFCA)

The Rural Business Development Grant award evaluated three distinct livestock processing models:

- 1. New regional processing facility
- 2. Expansion of an existing processing facility
- 3. On-farm processing facility development and expansion

Those producers who indicated willingness during the various livestock summits were encouraged to continue their input during this process. Many aspects of the project were completed. With the onset of the COVID 19 pandemic, the study was not able to fully identify all aspects originally identified for the study. (study results attached).

Upon completion of the KDC portion of the project, NJDA and Rutgers Cooperative Extension (RCE) identified various segments of the study that needed additional research and development. In March and April 2021, a survey of livestock producers across the state was conducted to determine the essential needs (study results attached).

During fall 2021, an outreach by the Department to individual producer businesspeople was conducted. Select producers who had extensive business development experience were given the opportunity to step forward to lead the project to establish what was considered the best option for the state's processing needs and establish one or two regionally centered livestock processing facilities.

From the continued work, the proposed livestock harvest and processing plant is now sized at 4,200 beef cattle, 1,200 hogs, and 7,200 lambs and goats per year housed in a facility of approximately 24,500 square feet (32,000 square feet with animal pens) with a scope of harvesting 25 beef units per day. Though small in the grand scale of processing, this will be a considerable support facility for processing both custom harvested and labeled meats and meat products to serve regional livestock producers that direct sell meats to consumers, as well as establishing a direct wholesale market for a producer house-branded product for all the species.

This potential product being funded will also serve as training for the agriculture industry, community college, and local vocational programs, with a classroom designed into the plant.

As you can see from the supporting documents and the application, this has had extensive study and support from multiple state and federal agencies in support of the New Jersey livestock industry. Our continued support of such a project is warranted to sustain a local sustainable food supply, while promoting environmental stewardship.

Again, I wish to convey the support of the state and this Department in the funding of this grant application to its fullest extent possible.

On behalf of North Jersey Resource, Conservation & Development (North Jersey RC&D), I am writing to express support for the proposed Northwest Food Processing & Innovation Center MPPEP grant application.

North Jersey RC&D is a regional 501(c)3 agricultural non-profit with 35 years' experience working with farmers in Northwestern New Jersey. Our organization works at the forefront of soil health and regenerative agriculture practices in the region, leading both a Regenerative Farm Network focused on supporting farmers learning and working closely under a NRCS Climate Smart Commodity Opportunity focused on providing technical assistance and marketing opportunities for 20 grass-fed livestock producers.

Through these projects, farm product diversification and the transition to sustainable rotational grazing is encouraged; management practices that rely on local, high-quality livestock processing facilities to be successful. The lack of a regional processing facility is a major hurdle for producers to be able to expand their livestock operations and make their farming profitable. It is also a major hurdle that prevents new and beginning farmers from entering the industry or diversifying their operations.

The need for livestock processing capacity in New Jersey is long-standing and significant. Producers continue to mention the need for additional livestock processing opportunities. Producers are currently required to haul livestock out-of-state for processing under USDA inspection in order to sell direct to consumer. Farmers are faced with significant logistical hurdles including capacity and scheduling challenges which, if left unaddressed, could result in a significant diminution of both current and future opportunities for the industry.

The development of an in-state, regional processing facility will not only support continued livestock operations in New Jersey but it will also encourage growth, farm diversification, and

pasture management and grazing conservation practices. These practices support improved soil health, improved water quality, as well as, additional ecosystem benefits.

On behalf of the New Jersey Highlands Water Protection and Planning Council (Highlands Council) I am writing to express our support for the proposed Northwest Food Processing and Innovation Center MPPEP grant application.

The Highlands Council is a regional planning agency that works in partnership with municipalities and counties in the 860,000-acre Highlands Region to encourage a comprehensive regional approach to implementing the 2004 Highlands Water Protection and Planning Act (Act) and associated Regional Master Plan (RMP). Implementation of the Act and RMP occurs through municipalities and counties via grants to conduct planning, engineering, and design activities that promote the preservation of natural resources, protect the quantity and quality of drinking water that serves over 70% of New Jersey residents, and ensures the economic viability of the Region. Our 2021 Economic Sustainability Plan recognized agriculture and agritourism as one of the Region's leading economic producers, though the industry is continually threatened by development. The continued economic viability of the industry hinges on providing the appropriate value added and support services to remain profitable.

Recently, the Highlands Council awarded six agricultural sustainability grants worth a total of \$650,000 in this fiscal year. Recognizing the urgency of this project the Highlands Council awarded the largest sum of \$150,000 to the Northwest Food Processing and Innovation Center. This project will bolster the Region's agricultural infrastructure by creating a USDA inspected livestock processing facility within proximity of the state's largest cattle producers while reducing the need for out-of-state processing which is both logistically challenging and resource intensive.

The Highlands Council fully supports this project for sustaining and enhancing the viability of agriculture in the New Jersey Highlands, supporting long-term economic growth, and promoting the protection of natural resources.
